- President Herb Heyne made opening remarks and went through the Agenda for today's meeting. Motion was made by Diane Goetsch and seconded by John_____ to approve today's Agenda. There was no further discussion on the motion. Motion passed unanimously.
- o It was announced that a quorum for this morning's meeting was reached for voting purposes.

APPROVAL OF 2023 ANNUAL MEETING MINUTES DATED: JANUARY 29, 2023:

 A copy of the 2023 Annual Meeting Minutes dated January 29, 2023, were included in the packet of information distributed to the congregation this morning for review. President Herb Heyne asked if there were any questions, additions, or corrections to be made to these minutes. There weren't any. Motion was made by Mark Clark and seconded by Jonnie Malm to approve the minutes. There was no further discussion on the motion. Motion carried unanimously.

NOMINATIONS FOR CONGREGATIONAL COUNCIL & BALLOTING:

- President Herb Heyne read the names of the nominees for one open position on the Church Council this year:
 - Mark Clark
 - Phil Bickley

Their photos and biographies are presented in today's Annual Report. Both nominees were present in person at today's meeting.

- There are 3 Council members leaving as their terms in office are up: Pam Clark, Jeanne Willems, and Vicki Mrotek.
- President Herb Heyne asked if there were any other nominations from the floor. He is required
 to ask that question three times. There weren't any. Nominations for office were then closed
 and the balloting was closed. The ballots were collected to be counted while the meeting
 continued from the floor. Results will be announced later in the meeting.

APPROVAL OF VOTING MEMBERS FOR SYNOD ASSEMBLY ON MAY 20, 2024:

- The following is a list of the voting members from our congregation who will be attending the Synod Assembly this year on May 20, 2024, in Appleton: Phil Bickley, Helen Bickley, Denise Skare, Bob Wiederhoeft, and Terri Wiederhoeft.
- Motion made by Mary Wittich and seconded by Debra Shafranski to approve the names of the congregants who will be attending the Synod Assembly on May 20, 2024. There was no further discussion on the motion. Motion carried unanimously.

PRESENTATION OF NARRATIVE BUDGET & APPROVAL OF 2023 SPENDING PLAN:

- Mark Gleisner, chairperson of the Finance Ministry, narrated the 2023 Annual Spending Plan together with a power point presentation to the congregation.
- The proposed Budget/Spending Plan for 2024 is **\$548,000**. Mark went through the five spending categories outlined in the pie chart and what percentages are projected to be spent:

Congregational Support: 24%Service: 12%Worship: 30%Learning: 22%

➤ Witness: 12%

As projected the Operating Income matches the Operating Expenses which means this is a balanced Spending Plan.

- Motion made by Keith Rusch and seconded by Ken Landwehr to approve the 2024 Narrative Budget as proposed at today's meeting. There was no further discussion on the motion. Motion passed unanimously.
- The meeting was opened up to the congregation for any questions or suggestions. There were none.

APPROVAL OF CONSTITUTION UPDATES:

President Herb Heyne read the constitutional amendments to be approved at today's meeting:

Every 3 years at Churchwide Assembly amendments to the provision of the Model Constitution for Congregations are submitted and approved. The most recent amendment is to the Model Constitution were approved in August of 2022. Saint Andrew Council has approved and recommends to the congregation that the amendments to the mandatory provision (as summarized in the document Amendments to the Model Constitution for Congregations 2022) be adopted by Saint Andrew Lutheran Church.

Reference was made to our constitution:

*C16.04 – This congregation may be amended to bring any section into conformity with a section or sections, either required or not required, of the *Model Constitution for Congregations of the Evangelical Lutheran Church in America* as most recently amended by the Churchwide Assembly. Such amendments may be approved by a majority vote of those voting members present and voting at any legally called meeting of this congregation without presentation at a prior meeting of this congregation, provided that the Congregation Council has submitted by mail or electronic means, as permitted by state law, notice to this congregation of such an amendment or amendments, together with the council's recommendations, at least 30 days prior to the meeting.

Motion made by Bob Wiederhoeft and seconded by Pam Clark to approve the amendments to our constitution to be in conformity with the Model Constitution for Congregations.

 Saint Andrew Lutheran Church Council also approved and now recommends the following three amendments our constitution which we will approve *en bloc*:

To further clarify the term of an endowment committee member:

C5.05.03 b) No Committee member shall serve more than 2 (two) consecutive 3 (three) year terms plus any time fulfilling a term due to a vacancy.

To remove Finance Ministry approval of Endowment Committee grant recommendations;

C5.05.04 f) Submitted grant requests will be received by the Endowment Committee who will research and make their recommendation to Council for action. This process can take place any time during the year.

To be in conformity with mandatory provision **C5.04** where it states the congregation elects among its voting member laypersons to serve as voting members of the Synod Assembly. This council responsibility was amended to

C12.04 k) To appoint the required number of voting members and a like number of alternates to the Annual Synod Assembly in the event voting members were not elected at the annual congregation meeting.

Motion made by Mark Clark and seconded by Dan Malm to approve the amendments as presented at today's meeting. There was no further discussion on the motion. Motion passed unanimously.


